This Plan of Merger (this "*Plan of Merger*") dated as of September 9, 2016 is made between Yellowstone Association, a Wyoming nonprofit corporation ("*YA*") and Yellowstone Forever, a Montana nonprofit corporation ("*Yellowstone Forever*").

**RECITALS**

- A. YA is a nonprofit corporation, organized and existing under the laws of the State of Wyoming.
- B. Yellowstone Forever is a nonprofit corporation, organized and existing under the laws of the State of Montana.
- C. The Montana Nonprofit Corporation Act and the Wyoming Nonprofit Corporation Act (collectively, the "*Acts*") each permit YA to merge with and into Yellowstone Forever.

- E. The board of directors of each of the Companies have considered and approved this Plan of Merger.

**AGREEMENT**

**SECTION 1. PARTIES TO THE MERGER.** The parties to the merger transaction consummated in accordance with this Plan of Merger (the "*Merger*") are YA and Yellowstone Forever.

**SECTION 2. SURVIVING CORPORATION.** The surviving corporation in the merger shall be Yellowstone Forever.

**SECTION 3. TERMS AND CONDITIONS OF THE MERGER.** As of 12:01 a.m. on October 2, 2016 (the "*Effective Date*"), the effect of the Merger shall be as provided in the Acts and all of the rights, privileges, and powers of YA and all property, real, personal, and mixed, and all debts due to YA, as well as all other things and causes of action of YA, shall be vested in Yellowstone Forever and shall thereafter be the property of Yellowstone Forever as they were of YA. The title to any real property vested by deed or otherwise in YA shall not revert or be in any way impaired by reason of the Merger. All rights of creditors and all liens upon any property of YA shall be preserved unimpaired. All debts, liabilities, and duties of YA shall attach to Yellowstone Forever and may be enforced against Yellowstone Forever to the same extent as if said debts, liabilities, and duties had been incurred or contracted by Yellowstone Forever. On the Effective Date, the separate existence of YA shall terminate.

**SECTION 4. FURTHER ASSURANCES.** Roger Keaton is authorized, for and on behalf of the Companies, to take all actions and to execute and deliver for filing all documents necessary to the completion of the Merger including, but not limited, to articles of merger.

**SECTION 5. GENERAL PROVISIONS.** This Plan of Merger may be executed in any number of counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute

one and the same instrument. A facsimile and email transmitted signature shall constitute an original signature. The Plan of Merger is subject to the Uniform Electronic Transactions Act.
